

# AKC Code Of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it
  might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

Entries close 12:00 Noon Eastern, Wednesday February 26, 2025 at the home of the Show Secretary, or when the entry limit of 100 dogs per show is reached, whichever comes first, after which time entries cannot be accepted, cancelled or substituted EXCEPT as provided for in Chapter 11, sec 6 of the rules applying to dog shows.

#### JUNIOR SHOWMANSHIP COMPETITION

Junior Handlers who win a third Novice Class with competition present or a first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open, after the closing of entries for a show, ARE REQUIRED to transfer their entry from the Novice Class to the Open Class. Junior MUST NOTIFY the Superintendent/Event Secretary prior to the judging of the class at the show.

AKC Junior Handler Numbers are now required for entry in Junior Showmanship Competition. Numbers may be obtained from the American Kennel Club - PHONE: (919) 233-9767.

Entry blank MUST be filled out with the necessary information, otherwise the entry in Junior Showmanship will not be accepted.

**NOVICE CLASS:** For Boys and Girls who are at least 9 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places in a Novice Junior Showmanship Class with competition present at a licensed or member show.

**OPEN CLASS:** For Boys and Girls who are at least 9 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Places in a Novice Junior Showmanship Class with competition present at a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open Class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 60 days from the date of the show where the Junior completed the requirements according to their records.

**MASTER CLASS:** This class will be for Boys and Girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

#### **NOTICES**

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

JUNIORS WITH A DOG ALSO ENTERED IN ANOTHER CLASS OFFERED AT THIS SHOW WHO SUBSTITUTE A DOG NOT ENTERED IN THIS SHOW MUST REMIT THE DIFFERENCE BETWEEN JUNIOR ONLY AND JUNIOR AS AN ADDITIONAL CLASS ENTRY FEE. JUNIORS WHO HAVE ENTERED JUNIOR SHOWMANSHIP ONLY WHO THEN SUBSTITUTE ANOTHER DOG WILL NOT BE CHARGED A FURTHER FEE.

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form.

Dogs entered in the Amateur-Owner-Handler (if offered \*\*\*) class will automatically be marked as eligible

to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in any NOHS competition during the entire show. For a detailed description of the National Owner-Handled Series, please visit the AKC website NOHS pages at:

\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

\*\*A current assistant is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

\*\*\* Amateur-Owner-Handler class is not offered at these shows.

Entry into NOHS is NOT automatic.

Remember to check the box near the bottom of the entry form if eligible.

No trailers or Motor Homes Permitted. **No Electric Hook-ups** Limited number of spaces are available and will be filled on a first applied, first awarded basis and must be for all five days. Cost \$75.00.

#### **RV PARKING**

Fee: RV Overnight Parking if pre-registered via www.sitecontrolservices.com by February 26, 2025 the fee is \$60.00 per night w/electric.

NOTICE: RV Electric hook up is a SINGLE 30 amp service (plug). If you use an additional 30 amp service (plug) for a "dogbone" or other use, you will be charged an additional \$25.00 per night. Overnight parking without pre-registration is \$60.00 per night plus \$10.00 per night for electric; CASH ONLY, no checks! There will be waste water pump out service this year but due to rising costs and inadequate participation the cost may be high. The on-site dump station is NOT to be used as no water is available to clean up.

Parking spaces may not be reserved unless there is advanced reservation. Anyone who wishes to park together make a notation on the Notes area during checkout on sitecontrolservices.com site.

Any vehicle registering for a handicapped space must send a copy of their official "Handicap Certificate" with their registration form. You must possess the required documentation when you arrive and the handicapped individual must be traveling with the vehicle to be eligible for this space. The handicapped spaces are limited and will be issued on first reserved basis. Only one additional vehicle is permitted per RV space reserved.

Spaces will be available from 2:00 P.M. on Tuesday, March 11, 2025. There will be a staging area for vehicles arriving prior to that time; staged vehicles will be parked in the order arrived. RV'S MUST ENTER GATE 6 FROM HIGHLAND AVENUE. NO EXCEPTIONS.

AN AKC RECORDING FEE OF \$.50 and an AKC EVENT SERVICE FEE of \$3.00 per entry will be required for the first entry of each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test (American Kennel Club Rule, Chapter 14, Section 2). This Recording Fee is to be collected by the Show-giving Club and paid to the American Kennel Club. Additional entries of the same dog will have an AKC Event Service Fee of \$3.50 per dog.

NO ENTRY shall be made and no entry shall be accepted which specifies any condition to its acceptance.

RETURNED OR POST DATED CHECKS do not constitute a valid entry fee. The Middle Atlantic Saint Bernard Club will add a \$20.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

NO REFUND FOR DUPLICATE ENTRIES Every effort will be made to find all duplicate entries, but if an entry has been processed, no refund will be made.

ERRORS ON ENTRY BLANKS – Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

CONSULT JUDGING PROGRAM FOR TIME OF JUDGING. DOGS MAY ARRIVE any time prior to their scheduled time of judging. DOGS NOT REQUIRED for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS - Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the Event Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged or when in the exercising ring.

ALL CASH PRIZES will be paid in the ring to the person showing the dog.

Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Ch. 11, Sec. 15 of the Rules Applying to Dog Shows.

Only dogs eligible for these shows will be admitted into show area. There is no provision for unentered dogs.

LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, proof of rabies vaccination may be rquired at the site. Exhibitors should have proof of Rabies vaccination available for all dogs under their control.

#### ATTENTION EXHIBITORS OF FOREIGN DOGS

Effective August 1, 2024 the U.S. Centers for Disease Control and Prevention (CDC) is expanding requirements for the importation/entry of foreign dogs into the United States. Requirements include that all dogs must be at least 6 months of age, microchipped, complete new CDC Dog Import forms, and have a valid rabies vaccination or be able to demonstrate residence in a DMRVV (canine rabies)-free or low risk country for the last 6 months. The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owner's records.
